Gentlemen:

The State Highway Department has notified me under date of February 21, 1938, that they have certified the dedicated streets and alleys in recorded plats in Royal Oak Township and that the same has been determined and fixed at 181.42 miles.

According to the suggestion of Judge Doty, which suggestion was tentatively agreed to by Mr. Cram, your attorney, the county will take over the subdivision streets and alleys immediately upon the filing of the certification by the State Highway Department.

I presume your next step is to comply with the provisions of Section 3993, Compiled Laws for 1929, which provides for the publication of the determination to take over the subdivision streets and alleys, which publication is to run for three weeks in succession.

Will you kindly notify me as to the paper in which the matter is being advertised so that we may make our plans accordingly.

Will you kindly acknowledge receipt of this letter and if there is anything further you desire on the part of the township, we shall be more than glad to cooperate with you to bring this matter to a conclusion.
